**Quakertown Alive! is celebrating over 25 years in downtown Quakertown and invites local non-profit organizations to participate in our annual Arts Alive! Arts and Crafts Festival on May 16, 2026!**

The entry fee, which entitles the applicant to a 12' x 12' display area, is \$50. The entry fee for a 12' x 24' space **OR** a 12' x 12' space for a vendor outside of Quakertown/18951 is \$90. We will not be offering electric hookups for vendors at this time. Only one vendor is permitted per space.

Checks should be made payable to Quakertown Alive!. There is a \$25 fee for returned checks due to insufficient funds. If your application is accepted, your entry fee will be processed, otherwise your check will be returned to you. Applications will be reviewed in a timely manner by a representative of the Events Committee. Vendors will receive confirmation emails.

**All vendors must agree to the attached Vendors Terms and Conditions. This application will *not* be considered complete without the *signed* agreement on the last page.**

Our rain date for this event is Sunday, May 17<sup>th</sup>, 2026 from 10:00 a.m. to 4:00 p.m. If you cancel and do not attend the rain date, you will *not* receive a refund. In the event that both dates need to be cancelled by Quakertown Alive!, we will refund *half* the vendor fees upon request by letter with a self-addressed stamped envelope or email within 30 days. Any monies not requested to be refunded will be considered a donation to the programs of Quakertown Alive!, a 501(c)(3) non-profit organization.

Spaces are in the street, do not block the sidewalk. The display area assigned to accept entrants must be manned throughout the entire show. The accepted applicant must provide his/her own canopy, table, tent, weights, and display. Be prepared for an outdoor event, including wind gusts and fluctuating weather. Tents/canopies **MUST** be secured with weights. Quakertown Alive! will have a designated safety officer patrolling the event to check on tent weights.

## QUAKERTOWN ALIVE! TERMS AND CONDITIONS

- 1.) Quakertown Alive! reserves the right to deny or accept any vendor application.
- 2.) The event committee will assign space locations to the vendors. The committee can take special requests into consideration, but there is NO guarantee. Space assignments are final.
- 3.) All vendors are required to remain open during the entire length of the event.
  - Arts Alive! – 10:00 a.m. to 4:00 p.m.
- 4.) Vendors must adhere to the set-up times. NO early birds.
  - Arts Alive! set-up begins at 7:30 a.m., and vendors must be set up by 9:30 a.m.
  - Food trucks may start entering at 7:30 a.m., and must be parked by 9:00 a.m.
- 5.) It is the sole responsibility of each accepted vendor to obtain any and all required, applicable, and appropriate state and local licenses / permits needed. Each vendor also bears the sole responsibility for payment of all taxes pertaining to their operation.
- 6.) All structures and sundries (tents, tables, chairs, trash cans, weights, etc.) are to be supplied by the vendor and are the responsibility of the vendor. All tents must be secured with weights to withstand changing weather conditions. Quakertown Alive! will have a Designated Safety Officer patrolling the event to check on tent weights.
- 7.) Vendors agree to assume all liability for and agree to indemnify and hold harmless all organizations and persons sponsoring, managing, or in any other way participating in the Arts Alive! Festival, including, but not limited to, Quakertown Alive! and its personnel and Quakertown Borough from any seen or unseen injury, theft, or other loss to any person or property incurred by them or their representatives during travel to / from, load in / set up, event, and break down, claim, penalty, or lawsuit in any way arising from operation or involvement in the Arts Alive! Festival.
- 8.) If Quakertown Alive! cancels the event, the vendor will receive a refund of half the vendor fees upon request by either letter or email ([alyssa@quakertownalive.com](mailto:alyssa@quakertownalive.com)) within 30 days. Any fees that have not been requested for a refund will be considered a donation to Quakertown Alive!.
- 9.) Quakertown Alive! events are family friendly. We reserve the right to decide if a questionable item / service is allowed at our organization's event. All decisions are final.
